2. Your broker needs to fax this form to Pat Shellard, Pinnacle Correspondent Services, at 604-709-5833 AND to West Coast Environmental Law at 604-684-1312.
3. Once the securities have been transferred to West Coast Environmental Law's brokerage account, our agent will advise us in writing of the receipt of the securities and the closing bid value on the day the securities were received into our account, or the market opening the next business day if securities are received after markets have closed.
4. We will issue an official receipt to you, for income tax purposes, for the value as determined by our agent.
5. It is West Coast Environmental Law's policy that securities, once received by our organization or our broker, will be sold as soon as possible.
